We hereby submit our intimation for your kind records and compliance. We assure you that we shall adhere to all environmental norms and maintain a clean and safe working environment.

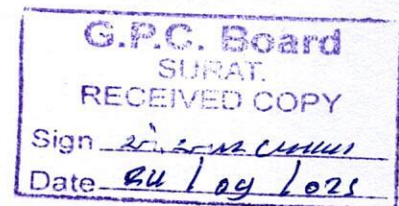
